

TERMS and CONDITIONS

For good and valuable consideration including the use and enjoyment of this website, the receipt and sufficiency of which is acknowledged, you hereby grant an exclusive, perpetual, worldwide irrevocable license to Z2H and Creator to use and commercially exploit any and all creative contributions, whether they be artistic, literary, dramatic, musical or otherwise in nature, created, suggested, added or contributed to by you to this website (the "Creative Contributions"), such irrevocable license to be effective upon the fixation of any Creative Contributions in any media.

You represent and warrant that:

- you have the irrevocable power and authority to enter into this License Agreement;
- all Creative Contributions shall be wholly original to and wholly-owned by you;
- you are participating on this website for enjoyment and fun, and not for compensation or credit of any kind;
- you are of the age of majority in the jurisdiction in which you reside and have the legal capacity to enter into this License Agreement;
- you waive any and all "moral rights" or any like right of intellectual property under any statute or law in any jurisdiction worldwide in respect of your Creative Contributions;,

You hereby waive any and all right to injunctive or equitable relief in respect of any disputes or claims over this License Agreement and the Creative Contributions and any use of same by Z2H and Creator, their successors, licensees and assigns, in future. In the event Z2H or Creator shall breach this License Agreement your sole remedy shall be an action at law for money damages: and in no event will you rescind or terminate this License Agreement.

Z2H and Creator have no obligation to use, produce, post or commercially exploit any Creative Contributions.

Z2H and Creator may sub-license, assign or otherwise transfer any right herein granted, and any assignee may further assign some or all of such rights to other assignees.

You indemnify and hold harmless Z2H and Creator, their successors, assigns and licensees, their directors, officers, and employees from and against all claims, actions, demands, damages and expenses (including reasonable outside legal fees and expenses) which may arise from your breach of this Agreement.

AND THEIR PARENTS, AFFILIATES, OFFICERS, DIRECTORS, EMPLOYEES, AND AGENTS (JOINTLY AND SEVERALLY THE "RELEASED PARTIES") AND EACH OF THEM FROM ANY AND ALL CLAIMS, ACTIONS, DAMAGES, LIABILITIES, LOSSES, COSTS AND EXPENSES OF ANY KIND (INCLUDING, WITHOUT LIMITATION, ATTORNEYS' FEES AND COSTS) ARISING OUT OF, RESULTING FROM, OR BY REASON OF YOUR PARTICIPATION IN OR IN CONNECTION WITH THE CREATIVE CONTRIBUTIONS AND THE MATERIALS AND ANY OTHER MATTER SET FORTH IN THE AGREEMENT, including, without limitation, the selection process, the failure of Z2H to select you as a writer whose work is to be published, the cancellation of the campaign established on this website, the exercise Z2H or anyone else of any rights granted by you under this Agreement, or any taxes or other obligations you may incur as a result of your participation in this campaign, on any legal or equitable theory whatsoever (including, without limitation, negligence, fraud, misrepresentation, rights of privacy and publicity, defamation, false light, infliction of emotional distress, breach of contract, copyright infringement, and claims based on dissatisfaction with any published book) (collectively, the "Released Claims").
